Extended Hearing Not Permitted The Massachusetts Supreme Judicial Court has ruled it was not an abuse of discretion to deny an extension of time to file a Motion for Relief from Judgment. According to the SJC, “[t]he [motion] (1)... did not raise any factual issue which would entitle [the defendant] to the relief he sought, i.e., that the case had been wrongly dismissed as untimely because of a genuine mistake about the law; (2)... was not supported by any reasonable argument that the court had overlooked or overlooked the application of law to the facts of the case; and (3)... does not demonstrate the existence of a significant error in the judgment or order on which the motion is based.” In this case the defendant moved for relief after almost two years had passed and after the SJC had already issued an opinion on the motion to dismiss. The move is an attempt to circumvent the SJC’s determination that the motion for relief was not timely filed. In his ruling, the judge stated he believed it was “outrageous and disingenuous” for the defendant’s attorney to argue he was innocent of the charges in the case. The judge also noted that the defendant had filed the motion for relief “for no other reason than the fact that the case had been dismissed.” From this ruling, it seems the judge concluded that the defendant’s attorneys decided to spend the next two years working on the motion instead of defending the case and then waited to bring a motion for relief as a way to delay and/or avoid paying sanctions.
