The field of the invention relates generally to the simultaneous monitoring of objects, and more particularly, to a system for tracking the position of an object that is provided with a reference mark that can be periodically compared with corresponding reference marks on successive objects and that can be determined by time-of-flight to report the position of the object. The use of cameras to capture an object and provide an image is well known. The image of an object may be provided to another system to facilitate tracking of the object. In addition, the position of the object may be determined based on the image of the object. This position may facilitate mapping the object to be tracked. A common example of the use of a camera is to track the position of a vehicle or a train as they move along a track. It is useful to track the position of the vehicle along the track, as the position of the vehicle may affect operations of the vehicle or the track. To track the position of the vehicle, an image of the vehicle is captured and tracked. A train traveling along a railway is provided with a reference mark on the wheels of the train. The reference mark on the wheels allows a camera to position the reference mark within an image. By knowing the position of the wheels in the image, the position of the train traveling along the railway can be determined. This is a common system for determining the position of the train. One difficulty with this type of system is that the reference mark on the wheels is often not the same size as that of the reference mark on the vehicle. Thus, if the vehicle is perpendicular to the direction of travel, a longer distance is covered by
