The IRS announced that it has begun accepting changes to tax returns, and as a result, there are now monthly deadlines for submitting your returns. These deadlines apply to individuals who haven't filed a return in the previous 10 years, as well as those who have. As always, it's a good idea to file your return before the deadline to ensure that your taxes are accurate and that you're not left owing money. The Form 941 As of January 1, 2018, entities are now required to file the Form 941 by April 15 for the preceding calendar year. This is most likely to apply to your business. If you file a Form 941 for the previous year, you will have until January 31 to file it. With the annual deadline, it's a good idea to file your Form 941 by April 15 so you're prepared, but keep in mind that you can always file as late as April 30 for a 6-month extension. The Form 940 For individuals who haven't filed their taxes in the previous 10 years, the IRS has created monthly deadlines. The first of these will apply for 2019. The deadline for an individual filing a separate return and an individual filing a joint return is April 15. You'll also need to file a Form 940 by April 15, but the deadline is based on your marital status. For a married individual filing a separate return and a married individual filing a joint return, the deadline is April 15. For individuals filing a joint return, the deadline will be April 15 of the following year (this can be any year), plus extensions. The Form 945 For an individual not filing a joint return, the deadline for filing a Form 945 is April 15. For a married individual who is not filing a separate return, the deadline is April 15.
